

Monroe County Legislature Votes to Approve Moving Money From DHS to Other Departments

Earlier this week the full Monroe County Legislature approved the transfer of money from the DHS Safety Net Assistance program to fund other Monroe County Departments. Members from FSW spoke before the Human Services Committee and the Ways and Means Committee last month in objection to this transfer as we have been repeatedly told money in the DHS budget is limited for overtime and the reason for the overtime cuts in Financial Care Path was because of budgetary concerns. At this month's Legislature meeting our Mobilization Chair Jessica Kilpatrick spoke during the Public Forum, and many community members from throughout the area also voiced their objection to the transfer of funds.

The movement of money from DHS to other Departments is not unique, in fact it happens all of time. It is understandably frustrating to be told that there is no money in the DHS budget for certain things as money continues to be transferred to other Departments. At this month's Labor Management meeting Administration clarified that budgetary concerns were not the only reason for the decreased overtime, and further explained that increased overtime was denied in some instances as it was determined to not be justified, as well as some programs had to be prioritized over others.

If you are requesting overtime make sure you are incorporating all of the actions you need to catch up on, for instance if you need time during overtime to work on CSR's and Fair Hearings you should request that. It is incredible to believe that with all of the new people being trained and on 100% review and all of the recent promotions that Seniors requesting overtime to work on their regular work it would not be justified.





Labor Film Series: My Imaginary Country

1.5 million Chileans revolted in 2019 against the constitution, injustices and privatized pension system imposed during the Pinochet dictatorship. Filmmaker Guzmán, who had documented the CIA-inspired coup that deposed Salvador Allende's socialist government (The Battle of Chile) returned to his country to record this struggle, told through interviews with women participants: "There are flames that consume and flames that nourish." 
