

Dear Union Family,

A big heartfelt THANK YOU to everyone who has completed the bargaining survey! We need your input in order to fight for the best possible contract.

We were scheduled to begin negotiations today - unfortunately the date has been pushed back to MAY 31st 2023. We have decided to POSTPONE the rally that was scheduled for tonight at County Leg. Please feel free to still speak if you have already registered to do so.

As a result of the negotiations postponement the survey will be extended for 2 more weeks. The new Survey end date is April 23rd 2023. Everyone who completes the survey and provides their name will receive a red t-shirt. Many of you have asked when the t-shirt will come in, our plan is to order them after the survey is complete. We anticipate a 6 - 8 week turnaround time after we order them. So far we have about 250 responses, and the majority who answered were hired prior to 2016.

The Quarterly FSW General Membership Meeting is Wednesday April 19th at 5:30 pm. As a result of direct feedback from new hires there will be benefit reps available from FSW voluntary benefits beginning at 4:30 pm to speak with members about options available to them. This includes short term disability, long term disability, and life insurance. Feel free to stop by and ask them questions.

At the membership meeting we will also elect ONE delegate and ONE alternate to the CWA Convention. The CWA Convention will be held in St Louis, MO from July 10th - July 12th 2023. Our local has three delegates who can attend, the President is automatically assigned as a delegate. Since the previous Convention was moved to a virtual platform due to COVID the remaining delegate from that Convention will automatically attend this Convention (approved at a previous membership meeting).

At the membership meeting we will also be voting on our early and primary endorsement candidates and campaign donations. In addition to these two special agenda items we will cover the same items covered in other membership meetings. These include Treasurer's Report and Committee Reports.

As a reminder FSW will be hosting a Meet & Greet this Friday April 14th at the Union Hall. Come out and meet your FSW representatives. Hope to see you all soon!



FSW's First-Ever "Bread-and-Knowses" Quiz







FSW Political Endorsement Interviews

On Saturday April 8th 2023 the FSW Political Action Committee held the last round of early and primary endorsement interviews. First up we had our current County Executive Adam Bello, followed by a panel of current County Legislators William Burgess, Rachel Barnhart, Carolyn Delvecchio Hoffman, and Mercedes Vasquez Simmons. Lastly we had challengers Oscar Brewer Jr and Rose Bonnick on their own panel. The Political Action Committee voted on their recommendations, which will be heard at Executive Board next week, and ultimately approved by the membership at the General Membership Meeting on 4/19/2023.

Early voting in the primary election will be held June 17th - 25th and primary election day is June 27th. In order to be on the ballot candidates have to collect a certain number of signatures from registered voters of the party line they wish to run on. Signatures for the primary are due April 10th 2023. Once the signatures are counted and verified the ballots will be formed.

There will be more endorsement interviews for the general election held later this summer. If you would like to be involved in the Political Action Committee contact acting chair Santosha Kuykendall.



Saturday, April 15th in the 19th Ward, 12 - 3 PM:


